

CONGRESSWOMAN MOORE'S PRIORITIES FUNDED IN THE FY 22 LABOR-HHS Bill

Below are some of the funding priorities that Congresswoman Moore fought to have included or supported having included in this legislation. This is not a comprehensive list.

TRIO: \$1.3 billion, an increase of \$200 million

- Congresswoman Moore, a TRIO alum, spearheaded a [letter](#) earlier this year asking for increased funding for this program.

Funding to implement her Scarlett's Sunshine on Sudden Unexpected Death Act (P. L. 116-273)

- **HRSA:** \$5.1 million, an increase of \$4 million, to expand support and technical assistance to States and tribal communities and improve the availability of data on sudden unexpected infant deaths (SUID), including possible grants to support families who have experienced SUID by providing information, referrals, or peer or follow-up support services.
- **CDC Safe Motherhood and Infant Health:** Bill includes \$56 million increase includes report language directing portions of that funding to implement the Scarlett Sunshine Act, including the expansion of the SUID and Sudden Death in the Young Case Registry, to improve SUID prevention strategies.

CDC Childhood Lead Poisoning Program: Congresswoman Moore led a [letter](#) earlier this year to boost funding for this program. The bill would provide an increase of \$11 million.

- The bill makes clear that the additional funding would be used to expand direct CDC assistance and funding to more State and local public health departments. Congresswoman Moore spearheaded separate request calling for cities like Milwaukee to be able to benefit from direct CDC assistance. This is also a recommendation from the audit of the city's lead program by the Public Health Foundation.

Surveillance for Emerging Threats to Mothers and Babies (CDC): The bill would provide \$15 million, an increase of \$5 million. Congresswoman Moore led a [letter](#) asking for \$100 million for this program.

Child Marriage Study: The Committee report accompanying the bill includes a report requested by Congresswoman Moore on the status of child marriages in the United States, including information on the prevalence of child marriages that have received exceptions through parental consent, judicial approval, emancipation, or pregnancy. The report would include such marriages that take place through force, fraud, or coercion and examine efforts States have enacted to help identify and prevent such marriage of minors due to force, fraud, or coercion.

OTHER PRIORITIES

National Institutes of Health (NIH) – \$49 billion for NIH, a \$6.5 billion increase.

Centers for Disease Control and Prevention (CDC) –\$10.6 billion, a \$2.7 billion increase.

Child Care and Development Block Grant: \$7.4 billion, a \$1.5 billion increase.

Title I Schools: \$36 billion, an increase of \$19.5 billion

Special Education: \$17.2 billion, a \$3 billion increase.

Head Start: \$12.2 billion, a \$1.4 billion increase.

Pell Grant: Increases maximum award by \$400 to \$6,895. The bill would allow DACA recipients to receive Pell Grants.

AmeriCorps: \$1.3 billion, a \$194 million increase.

Low Income Home Energy Assistance Program: \$3.9 billion, a \$150 million increase.

Family Violence Prevention and Battered Women’s Shelters programs: \$463.4 million, a \$280 million increase.

Job Corps: \$1.83 billion, a \$81.4 million increase.
